# **EuroACE congratulates European Parliament for its economic rationale in calling for a Binding 40% Energy Efficiency Target and Sectoral Target for Buildings**

In its Plenary vote today on the 2030 Report (Delvaux/Szymanski), the European Parliament put its full weight behind the ITRE-ENVI Report calling for a binding 40% Energy Efficiency Target. EuroACE calls on the Commission and Member States to place Energy Efficiency and Buildings at the heart of the 2030 Climate and Energy Debate.

"The European Parliament has shown a clear vision and understanding of the current **economic dynamics** in the EU – **unlocking the available cost-effective energy savings potential in sectors like buildings** through a binding Energy Efficiency Target and a sectoral target for buildings is a no-brainer", affirmed Adrian Joyce, Secretary General of EuroACE, in his reactions from Strasbourg.

This vote is a clear signal demonstrating the political support for a new commitment on energy efficiency. It provides additional encouragement to the Commission to step up its ambition in defining a clear path for energy efficiency towards 2030, in the context of next summer's review of the EU's energy efficiency efforts.

EuroACE calls on the European Commission to take stock of the economic evidence and of the European Parliament's clear stance, and stands ready to support the Commission as it assesses the need for **bold legislation to drive the demand for further Energy Efficiency** in this Summer's efficiency review, with specific requirements for buildings as a major contributor to achieving a binding Energy Efficiency target, as stated in the EP's adopted Report.

Indeed, recurrent evidence from independent research institutes but also from the Commission's internal economic team have repeatedly preached about the **cost-effective benefits of Energy Efficiency and about the huge available energy savings potentials in buildings**.

In its 2030 Climate and Energy Package released on 22<sup>nd</sup> January, the European Commission's Impact Assessment indicated the **strong economic rationale behind setting ambitious legislation for Energy Efficiency**: "Higher efforts geared towards energy efficiency and renewable energy beyond what is needed to achieve a GHG target would result in higher benefits relating to e.g., improvements in fuel efficiency, security of supply, reduction of the negative trade balance for fossil fuels, environmental impacts and health." <sup>1</sup>

Evidence-based research from the recent Fraunhofer Report<sup>2</sup> had already demonstrated that without a binding Energy Efficiency Target, the EU will not achieve energy savings beyond the business as usual scenario.
